Workshop One:

WTF IS THE TECH BROLIGARCHY?

(a 90 minute workshop)

Description:

This workshop **examines the collusion of tech capital and political power at the onset of Trump's second administration**. Participants will be introduced to the defining features of an oligarchy and the 14 faces of the current Tech Broligarchy. A trivia game will help participants explore key business affiliations, investments, and political connections between the Tech Broligarchy and the Trump administration.

Essential Question: What is the Tech Broligarchy?

Key Points:

- Tech billionaires have accumulated more wealth than any group of individuals in human history. [Source](#)
- Beyond regular wealth inequality, oligarchies are formed by those who use their wealth as a form of political power.
- The 14 Tech Broligarchs are utilizing their economic and monopoly power over the digital world to exert control over our government and society to expand their wealth.

1. Defining Oligarchy & Introducing the 14 Tech Broligarchs (15 mins)
2. Tech Broligarchy Trivia Game (35 mins)
3. Group Discussion (20 mins)
4. Sharing Resources (5 mins)

Key Terms:

- **Collusion** – A cooperation between two or more entities, typically with a deceitful purpose and for some form of gain for the involved parties.
- **Oligarchy** – Oligarchy represents rule by a small, wealthy elite over the many. The distinguishing feature of oligarchs is not just their wealth, but how they use that wealth as a form of political power. Their primary motivation is protecting and expanding their wealth through political influence.
- **Monopoly** – A complete control of something, especially an area of business, so there is no economic competition.
- **Social Media Algorithms** – A technical means of sorting posts based on relevancy instead of publish time, to prioritize which content a user sees first. [Source](#)
- **Misinformation** – Information whose inaccuracy is unintentional, and spread unknowingly.
- **Disinformation** – Information that is deliberately false or misleading, often spread for political gain, profit, or to discredit a target individual, group, movement, or political party.
- **Cloud services** – Application and infrastructure resources that exist on the Internet. Third-party providers contract with subscribers for these services, allowing customers to leverage powerful computing resources without having to purchase or maintain hardware and software. [Source](#)
- **Big Tech** – A blanket term for the world's largest and most influential technology companies. The “Big 5” often refers to five companies – Amazon, Apple, Alphabet (which includes Google), Meta (formerly Facebook), and Microsoft. The “Malicious 7” can be expanded to include Nvidia and Tesla. The concept of Big Tech can also extend to the major Chinese technology firms—Baidu, Alibaba, Tencent, and Xiaomi—collectively referred to as BATX. [Source](#)

Agenda:

Defining Oligarchy & Introducing the 14 Faces of the Tech Broligarchy

(15 mins)

1) Ask folks if they have heard the term “tech broligarchy.” Where have they heard it and what has been said? If it’s unfamiliar, **what comes to mind when you hear the term “tech broligarchy”?**

2) Break down the terms:

What do we mean by Oligarchy? *Oligarchy represents rule by a small, wealthy elite over the many. The distinguishing feature of oligarchs is not just their wealth, but how they use that wealth as a form of political power. Their primary motivation is protecting and expanding their wealth through political influence.*

Facilitator Note: Make sure to emphasize that while wealthy people may lobby and try to influence politics, oligarchs are distinguished by their monopolies in key industries, which give them economic power that they wield for political power.

What do we mean by Tech Oligarchy? *The Tech Broligarchy are the billionaire owners, CEOs, and investors of the world's largest and most influential technology companies that are wielding their unprecedented wealth for political power. They are bros because their capitalist wealth-building project is rooted in white supremacy, patriarchy, and cis-white, male power.*

3) Proceed to give **Printout 1: The 14 Faces of the Tech Broligarchy** (see next page!).

Explain that contrary to any liberal tendencies Silicon Valley may have espoused in the past, these tech billionaires are moving in lockstep with Trump’s MAGA agenda since the results of the 2024 elections.

4) Ask participants to call out the names of the Broligarchs they recognize.

Tech Broligarchy Trivia Game

(35 mins)

- 1) Let folks know that we will play a trivia game to connect the dots on how the Tech Broligarchy are using their wealth to secure political power in Trump's administration.
- 2) Divide folks into groups of 3-5 people. Explain that you will ask a question, and the groups must consult together before raising their hand with an answer. If one group doesn't answer correctly, another team can have a chance to guess the question.
- 3) Briefly process the answers before proceeding to the next question.

Facilitator Note: The trivia game is designed to draw connections between the source of the Tech Broligarchy's wealth and what they have gotten — or are trying to get — out of a favorable relationship with the Trump administration. The examples will introduce the 14 Broligarchs and break down their key businesses and investments (e.g., social media, AI and data centers, defense tech, crypto, aerospace, etc.). It is important to note the symbiotic relationship between the Tech Broligarchs and Trump (i.e. lucrative government contracts for the tech bro companies, Twitter/X being a platform for the global right, Trump's investment in the Big 5 Tech companies, etc.)

Most of the members attended Stanford University or the University of Illinois, Urbana-Champaign. Group Discussion

(20 mins)

- What stood out to you in learning about the Tech Broligarchy?
- What are some of the sources of the Tech Broligarchy's wealth?
- In what ways are they using their wealth to expand their political power?
- How are the moves of the Tech Broligarchy showing up in your community?
- Have you seen organizing efforts against this oligarchy, or other authoritarian regimes globally, that you would like to share? *(If folks have trouble with this question, let them know we will explore how communities are fighting back in the next workshop.)*

Sharing Resources

(5 mins)

- 1) Pass out copies of the two Printouts – *Printout 2: Assets and Aspirations*, and *Printout 3: Broligarchy Connections to the Trump Administration*.
- 2) Explain that:
 - *Printout 2: Assets and Aspirations* breaks down the key businesses and investments of the 14 Tech Broligarchs and what they want from the Trump administration.
 - *Printout 3: Broligarchy Connections to the Trump Administration* lists at least 20 people in the administration who have a direct connection to the 14 Tech Broligarchs.
- 3) Say that you hope the information can help **break down the source of the Tech Broligarchy's wealth and inspire strategy and organizing to stop the destruction and devastation they cause.**

Closing "Head, Hand, Heart"

(15 mins)

Prep: On a newsprint, create three sections – Head, Heart, Hand. (Another option is to draw a person and write the words "Head, Heart, Hand" by the corresponding body part).

- 1) Instruct participants to take three post-it notes, and write a thought for each body part:

Head: What is something new that you learned today?

Heart: What is something you felt today?

Hand: What is something that you'll take with you from today?

- 2) As they finish writing, participants can put their post-it notes on the newsprint and read what others have written.

What are the key things they want from the Trump administration?

- Termination of DOJ probe into Tesla self-driving claims; elimination of autonomous driving car crash reporting by National Highway Traffic Safety Administration
- Implementation of a lax federal regulatory framework for autonomous driving to override state-by-state regulations.
- Limitation of tariffs, particularly against China, that might affect Tesla international supply chain; exclusion of Chinese EV companies from US market.
- More and larger federal contracts for SpaceX, in particular NASA, Air Force, and Defense Information Systems Agency; this entails a continued reconfiguration of federal contracting in favor of Commercial Off-The-Shelf (COTS) model pushed by VC to beat established prime military contractors.
- Federal spending cuts to agencies that are not of strategic importance to Musk via DOGE, as well as appointment of Musk allies to government posts.
- Elimination of CFPB due to potential oversight of X Money and Tesla Finance.
- Slow down momentum of xAI competitor OpenAI by regulatory or any other means.
- Consideration by Trump for major private-sector business deals, such as full or partial acquisition of TikTok or X Corp. merger with Trump Media & Technology Group (speculative).
- Federal regulatory and policy action in favor of widespread cryptocurrency adoption.

What are the key things they want from the Trump administration?

- More and larger federal contracts for Palantir, SpaceX, and Anduril (among other portfolio companies), in particular Department of Defense; this entails a continued reconfiguration of federal contracting in favor of Commercial Off-The-Shelf (COTS) model pushed by VC to beat established prime military contractors.
- Continued federal government support of VC-backed military start-ups through initiatives like the Defense Innovation Unit.
- Appointment of key allies to government posts to further policy objectives.
- Federal regulatory and policy action in favor of widespread cryptocurrency adoption and AI (sidenote: Thiel is an investor in Crusoe Energy Systems, which will be building Texas AI data center as part of Project Stargate).
- Permitting and regulatory easing for VC-backed nuclear power start-ups.
- Protecting carried interest loophole for PE/VC that Trump supports Congress eliminating.

 - Permitting and regulatory easing for VC-backed nuclear power start-ups.

- Establishment of an industry-friendly regulatory framework for AI and cryptocurrency; in particular, Andreessen is a major investor in Solana.
- Elimination of CFPB due to oversight of Andreessen Horowitz portfolio companies, including shutting down LendUp Loans in 2021.
- More passive support for contracting efforts of Thiel, Musk, and others that would support companies such as Palantir and SpaceX where Sacks is an investor.
- Favorable outcome for Meta in FTC antitrust lawsuit over Instagram and WhatsApp acquisitions, as well as other federal cases involving Andreessen Horowitz portfolio companies.

What are the key things they want from the Trump administration?

- More and larger federal government cloud contracts for Oracle.
- Under consideration by Trump for leading a full or partial acquisition of TikTok.
- Regulatory approval for pending, embattled merger of CBS Paramount and Skydance Media, controlled by Larry's son David Ellison.
- Favorable regulatory treatment for data center and AI projects (including Project Stargate).
- As an investor in X Corp., his interests are ostensibly aligned with Musk's in the social media space.

What are the key things they want from the Trump administration?

- Favorable regulatory treatment for US investments after making massive investment commitment in Project Stargate.
- A close relationship with Trump will help Son continue to raise money from major international investors.
- As the controlling shareholder of Arm Holdings via SoftBank, Son is reportedly positioning the chip design company from producing CPUs to also producing GPUs and thereby becoming a competitor to NVIDIA.
- SoftBank is positioning itself to make major investments in solar power, which will reportedly be an important energy source for US data centers constructed as part of Project Stargate.

What are the key things they want from the Trump administration?

- Favorable outcome for Meta in FTC antitrust lawsuit over Instagram and WhatsApp acquisitions.
- Protection against EU Big Tech regulation, in particular via Digital Markets Act and Digital Services Act, that may be heightened in retaliation for US tariffs on EU imports.
- Wants to prevent reforms to Section 230 (led by Trump's FCC Chair Brendan Carr) that might expose Meta to user-generated content liability and/or create controversy resulting in reduced advertising revenue. Also relevant is the status of AI-generated "user" content under content moderation.
- Favorable regulatory treatment for data center and AI projects, especially their energy requirements.

- Favorable outcome for Amazon in FTC case alleging monopolistic practices in online retail and technology.

Workshop Two:

WTF IS THE TECH BROLIGARCHY UP TO?

(a 90 minute workshop)

Description:

In this workshop, participants will review headlines from Trump's first 100 days in office to examine **how the Tech Broligarchy are exerting power through economic, political, and social control**. The group will also explore what resistance to this power looks like.

Essential Question: What does it look like for the Tech Broligarchy to exert power?

Key Points:

- Oligarchies exert power through economic, political, and social control.
- The Tech Broligarchy exercises economic control through digital data collection and monopolizing digital infrastructure.
- Their political control derives from strategic campaign contributions, securing positions in government, and providing tech weapons for policing, anti-immigration enforcement, and the military.
- Methods of social control include surveillance, controlling media narratives, and the ownership of communication platforms.

Workshop Activities:

1. The Oligarchy Playbook: How to Exert Power (20 mins)
2. The Nightmare that is the Tech Broligarchy (20 mins)
3. Group Discussion (20 mins)
4. The People Fight Back: Creating Our Own Headlines (30 mins)

Materials:

Newsprint, markers, tape. *Printout 4: Definitions. Printout 5: Headlines.*

WORKSHOP 2: WTF IS THE TECH BROLIGARCHY UP TO?

Key Terms:

- **Racial Capitalism** – Our current economic system, capitalism, is driven by profit-making through the exploitation of workers, the extraction of resources, and the hoarding of wealth by the few. Racial capitalism is a way of understanding how racism and capitalism work together to create the unjust conditions that we live under.
- **Digital data collection** – The process of gathering information electronically. Whenever we use the internet or even a digital streaming service, our data is collected by companies, and that data is sold for profit.
- **Digital infrastructure** – The physical hardware, labor, and software-based technologies that enable digital services. This includes cloud computing services and physical data centers that take up our land, water, and energy sources. It also includes the extraction of raw materials and minerals used to create digital technologies that are mined through extremely exploitative conditions in the Congo and assembled in harsh factories in China and elsewhere.

Facilitator Note: There may be moments in this workshop that are hard for participants as we will be discussing ways in which Trump and the Tech Broligarchy are exerting their power and inflicting harm and devastation on our communities. For the Nightmare that is the Tech Broligarchy activity, we encourage facilitators to choose headlines that work best for your group, and to take the time to breathe and share offerings of hope and stories of resistance, as needed.

Agenda:

The Oligarchy Playbook: How to Exert Power

(20 mins)

1) Remind participants that in the first workshop, we defined oligarchies as distinct from typical rich people because oligarchs are strategically using their wealth as a form of political power, seeking to rule society in order to guard and expand their wealth.

2) **Ask if anyone recalls any examples of how the Tech Broligarchy are using their wealth to gain power.** *(If folks don't remember any examples, say it's okay because we're going to be taking more about this today).*

3) Explain that while the Tech Broligarchs are unique to this time in history, they are also following the rules of the Oligarchy Playbook, passed on from oligarchs of the past and present, which is that:

Reveal the definition:

Oligarchies exert their power through economic, political and social control.

Remember, this is what makes them distinct from just regular rich folks – oligarchies are trying to rule society at large.

4) Let's break down the Oligarchy Playbook.

Number 1: What does it mean when oligarchs have economic control? *(i.e. control over the supply chain, owning the means of production, mass privatization, securing a monopoly to dictate price-setting, harsh labor practices, etc.)*

WORKSHOP 2: WTF IS THE TECH BROLIGARCHY UP TO?

Facilitator Note: A hallmark of oligarchy economic control is the heavy hand of monopolizing critical infrastructure and domination of labor conditions that lead to concentrated wealth in the hands of a small ruling class. The robber barons of the Industrial Revolution monopolized key infrastructure of oil, steel, and finance when the US transitioned from an agriculturally-based economy into one based on mechanized manufacturing and large-scale industry. Racist laws enacted after slavery that undermined the rights and freedoms of Black folks, combined with the harsh exploitation of immigrant labor, allowed the robber barons to amass immense wealth, which they used to wield power over society at large. [Source](#)

The Tech Broligarchy's rise comes during the Digital Revolution, when our society is moving from a mechanical and analog world into one where everything is digital. Parallels to the robber barons include their monopolization of digital resources and infrastructure, including cloud computing services and physical data centers that take up our land, water, and energy sources. It also includes the extraction of raw materials from indigenous lands, and exploitative labor conditions in the Congo, in factories in China, and elsewhere.

So what does economic control under the Tech Broligarchy look like today?

Reveal the definition and ask someone to read it aloud:

The Tech Broligarchy controls the ECONOMY through digital data collection and monopolizing digital infrastructure.

Can anyone break this down?

Digital data collection is the process of gathering information electronically. So anytime you use Google Maps, count your steps, search for something online – companies are collecting that information (which they call data) and selling that information (or data) for profit.

Digital infrastructure includes everything from the actual devices and software created to the labor of all the people along the supply and production chain who help create these digital technologies. *We'll explore this further in our next activity....*

WORKSHOP 2: WTF IS THE TECH BROLIGARCHY UP TO?

When we say the Tech Broligarchs have economic control, it's all of this. Having control over the supply and distribution of items, the use of natural resources, and the labor that makes these digital technologies.

5) Okay, moving on to the next form of control.

Number 2: What does it mean for an oligarchy to have political control? (*i.e., not even pretending to have accountability to the masses, deciding the rule of law — who's criminalized, who's allowed to vote, which countries are recognized, securing government positions, power to wage imperialist projects and wars, etc.*)

Facilitator Note: A striking feature of oligarchy rule is that they are not accountable to the masses – they move with impunity, deciding the fate of humanity and the planet without care.

And what does this look like under the Tech Broligarchy? Reveal the definition:

The Tech Broligarchy controls POLITICS through political contributions, holding government positions, and providing tech infrastructure to the police, anti-immigration enforcement, and the military.

In the first workshop, we discussed examples of political power such as the Tech Broligarchy's contributions to Trump's 2024 campaign, the 29 appointed positions in the Trump administration with direct ties to the Tech Broligarchy, and the massive government contracts many of the Tech Bros have.

WORKSHOP 2: WTF IS THE TECH BROLIGARCHY UP TO?

6) Lastly, **Number 3: What do we mean by an oligarchy having social control? What are the means by which a small group of people could control the masses, and what does that look like?** (i.e. police and prisons, surveillance, banning of gender-neutral bathrooms and books, cultural attire, use of media to promote dominant interests and values, using algorithms to facilitate consumerism, etc).

Facilitator Note: Social control is about ensuring that the systems and institutions that hold up society (i.e. court system, media, schools, libraries, hospitals, etc) are working to promote the ideology and economic projects of the oligarchy. In the society that we live under – racial capitalism – race, gender, class, and ableism become the vulnerabilities and battlegrounds on which the oligarchs seek to create hierarchies to justify their elite superiority and control the masses.

And what does social control look like under the Tech Broligarchy? Reveal the definition and ask someone to read it aloud.

The Tech Broligarchy implements mechanisms of SOCIAL CONTROL through surveillance, controlling media narratives, and ownership of communication platforms.

We've been seeing social control with the ways states are trying to criminalize women seeking reproductive care by tracking their phones, or ICE grabbing folks off the street and trying to disappear or deport them without any due process. Together, these three forms of control are the ways the Tech Broligarchy are exerting their power, attempting to have control over all these aspects of society.

7) Explain that we're going to move into an activity that will allow us to take a closer look at the ways the Tech Broligarchy have been trying to exert power during Trump's first 100 days.

Directions: These definitions can be printed and hung up for Workshop 2: Oligarchy Playbook

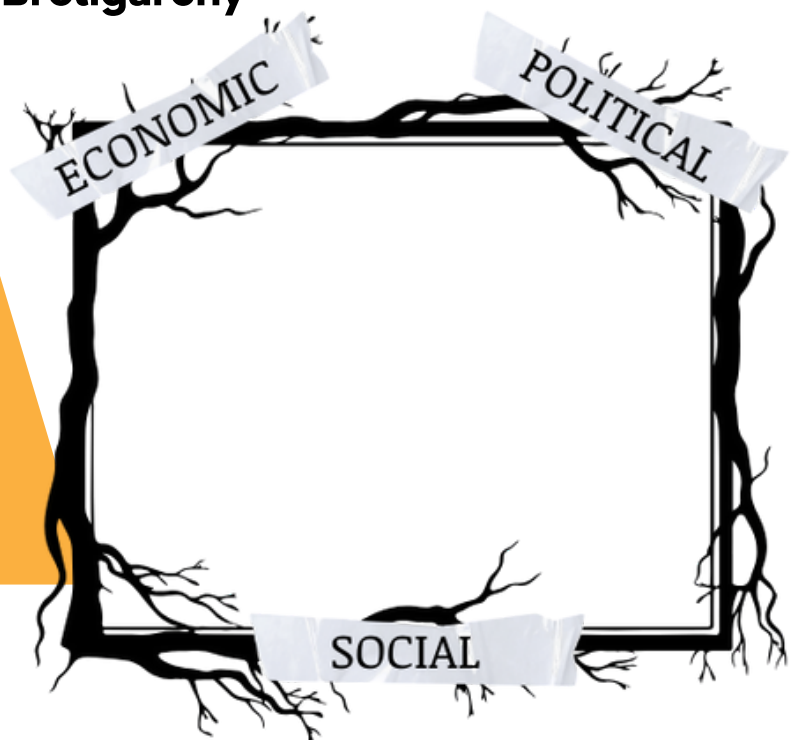

The Nightmare that is the Tech Broligarchy

(20 mins)

Prep: On a newsprint, draw a shadowy box and write the three arms of control around the frame: economic, political, and social. The goal is to create a “nightmarish” container to place the headlines for this activity. Here is an example, but feel free to make it your own.



- 1) Introduce the ‘Nightmare that is the Tech Broligarchy.’ Show folks that it’s comprised of three arms of control – economic, political, and social control.
- 2) Explain that we are going to be looking at headlines from Trump’s first 100 days in office and discuss the ways in the which the Tech Broligarchy are exerting power through these three arms of control – economic, political, and social control.
- 3) Explain that a volunteer will pick out a headline, read it aloud, and share their thoughts on the type of control the headline demonstrates. Let them know that some headlines might reveal multiple methods of control as it’s all one nightmarish monster, and the forms of control inform each other.
- 4) After sharing their reflections on what type of control the headline reveals, they can tape the headline onto the newsprint by the form of control it evokes.

WORKSHOP 2: WTF IS THE TECH BROLIGARCHY UP TO?

5) Model an example:

Read the headline:
(this is the first of the headlines that were cut up).

Google's former CEO: AI advances are more important than climate conservation

Share that this headline demonstrates “economic and social control” because economically – Google is saying it’s prioritizing it’s profits above any considerations for the climate crisis that we’ve unleashed onto the earth. The economic control leads to “social control” because the opinion of Google’s former CEO is given space in a mainstream media source (a popular, corporate blog), so that narrative is enforced that AI development supercedes our planet.

Tape the headline somewhere into the Nightmare frame.

Ask if anyone see any other ways different forms of control are showing up in this headline.

6) Take a moment for any clarifying questions about the activity.

7) When ready, ask a volunteer to pick out a headline to read aloud. Remind the volunteer to share what type of control they see through the story of the headline, and to place it into the Nightmare frame by the kind of control.

8) Give the group a moment to add any comments about other forms of control that might be showing up in this headline.

9) Continue with other volunteers until you feel the group's energy is ready to transition to the next activity.

Group Discussion

(15 mins)

- What themes or patterns stood out to you?
- How does economic control influence the ways the Tech Broligarchy implement political and social control?
- How do these forms of control create varying levels of harm to us as individuals and in our communities?
- How does the role of technology in enhancing surveillance impact our society as a whole?

We all get caught in the web of digital harms as it touches us 24/7, an intrusion unprecedented in human history.

How do we break free from the digital control of the tech oligarchs? Explain that **people are resisting, and always have. Oligarchies have been toppled before.**

Invite folks to share any experiences surviving or helping topple oligarchies in other places.

The People Fight Back: Creating Our Own Headlines

(30 mins)

1) Explain that for our closing activity, participants will work in groups to create a headline foregrounding how they would like to imagine people fighting back.

2) Read some real-life examples to inspire the group:

Extended description: The small city of 70,000 residents discovered that millions of their tax dollars are funneled to Israel annually. In response, the city council suggested reallocating the funds to essential services like housing, healthcare, and education. Governor Abbott quickly condemned the move, calling it “antisemitic” and a violation of Texas state law, which bans government entities from supporting any boycott or embargo against Israel

3) Split participants into groups of 3-5 people. Let folks know they have 15 minutes to convene and imagine an intervention they would wage against the Tech Broligarchy. Once they have an idea, they can create a headline capturing their intervention, and they will present it back to the large group.

Invite folks to get creative—they can perform a skit, make a collage, or use whatever medium suits their needs.

4) After 15 minutes, convene everyone in one large group. Invite each group to present their headline and/or presentation of their intervention against the Tech Broligarchy.
